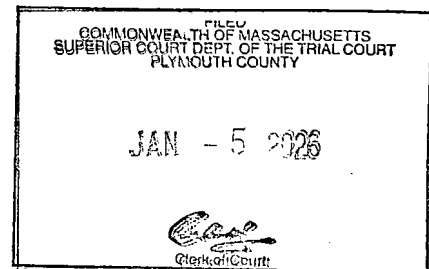

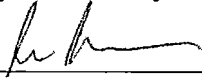
**JOINT MOTION TO CONTINUE HEARING ON KAREN READ'S MOTION TO

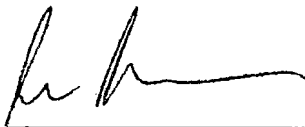
